

# Data Protection Declaration

In the course of your visit to our website, personal data such as your IP address will be collected. We handle the personal data collected from you on the basis of the following legal principles: [General Data Protection Regulation](#), GDPR for short and [Telecommunications Act 2003](#), TKG 2003 for short.

In this data protection declaration, we inform you about the most important aspects of data processing on this website, [taste-of-vienna.com](http://taste-of-vienna.com), whose owner is Fasten-Tour GmbH, based in Oberarnsdorf 14, 3621 Rossatz-Arnsdorf, Austria, Email [office@fasten-tour.com](mailto:office@fasten-tour.com).

If you contact us using the form on the website or by e-mail, the data you provide, such as IP address, name, address, telephone number and email address, will be stored with us for six months for the purpose of processing the request and follow-up questions. We do not pass this data on.

## Data storage

According to the provisions of Article 6 Paragraph 1 lit a and lit b of the General Data Protection Regulation, the processing of personal data of customers is lawful if it is necessary for the performance of a contract to which the data subject is a party or for the implementation of pre-contractual measures which are made at the request of the data subject and the data subject has given their consent to the processing of their personal data for one or more specific purposes.

According to [Section 96 \(3\) of the Telecommunications Act 2003](#), we are obliged to inform you which personal data we determine, process and transmit and on what legal basis and for what purposes this is done and for how long the data will be stored.

The personal data you provide are required to provide the pre-contractual information required by law, to conclude a contract if it comes to that and subsequently to fulfill the contract.

A data transfer to third parties takes place to the processing bank / payment service provider for the purpose of debiting the price, as well as to our tax advisor to fulfill our tax obligations.

## Retention period of the stored data

In the event of a contract being concluded, all data from the contractual relationship will be stored until the expiry of the tax retention period (7 years). Name, address, possibly purchased goods and date of purchase are also stored until the product liability expires (10 years).

If you cancel the shopping process on our website, your personal data stored by us will be deleted.

## Cookies

Our website uses so-called cookies.

What are cookies? Cookies are small text files that are sent to the user's browser together with the requested website. The browser is an access program for the home computer with which the Internet can be used. Well-known browsers are, for example, Internet Explorer, Safari or Mozilla.

What can cookies do? Cookies make it possible, for example, to fill your shopping cart when shopping online without having to identify yourself as the same customer on each sub-page of a retailer.

The user is "recognized" with the help of cookies.

In the context of cookies, we save the IP data of the subscriber as well as the name, address, telephone number and email address of a client.

We use cookies to make our offer user-friendly. Some cookies remain stored on your device until you delete them. They enable your browser to be recognized the next time you visit.

If you do not want this, you can set up your browser so that it informs you about the setting of cookies and you only allow this in individual cases.

If you deactivate cookies, that can limit the functionality of this website.

### **Your rights**

You can request information about your personal data that is processed and stored by us at any time free of charge. As the person concerned, you have the right to correct, restrict, delete and revoke your personal data, provided that there is no statutory retention obligation on our part.

As a data subject, you also have the right to request data transfer. We take appropriate measures to provide you with all information relating to the processing of your data, if you so wish, in a precise, transparent, understandable and easily accessible form in clear and simple language.
